Below are our cancellation and refund policies. You will received a signed copy of these on the first day of class.

**CANCELLATION POLICY**

Any student enrolled in a course canceled by the school will receive a full refund.

Any applicant who fails to make full payment prior to the beginning of class will be deemed to have withdrawn from class and shall be entitled to a refund of all monies paid minus 15% of the contract price of the course, but in no event will the school retain more than \$150.00.

Any applicant rejected by the school shall be entitled to a refund of all monies paid.

All monies paid by an applicant will be refunded if requested within three days after signing an enrollment agreement and making an initial payment.

An applicant requesting a refund after the three day period but before starting the course shall be entitled to a refund of all monies paid minus 15% of the contract price of the course, but in no event will the school retain more than \$150.00.

**REFUND POLICY**

The termination date for refund computation purposes is the last date of actual attendance by the student.

Students who terminate training during the first week will receive a refund of 90% of the contract price of the course minus \$150.00, but in no event shall more than \$350.00 be deducted from the original contract price of the course.

Students who terminate training from after the first week up through 25% of the course will receive a refund of 75% of the contract price of the course minus \$150.00.

Students who terminate training after 25% up through 50% of the course will

receive a refund of 50% of the contract price of the course minus \$150.00.

Students who terminate training after more than 50% of the course has been completed will receive no refund.

Any student enrolled in a course canceled by the school will receive a full refund.

The Jenks Hypnosis and Training Center LLC reserves the right to terminate any student for improper or disruptive behavior. Students who are terminated will receive a refund according to the refund policies.

In the case of a student's prolonged illness, accident, death in the family or other circumstance that makes it impractical or impossible to complete the course, he or she will be entitled to a refund that is fair to both the school and the student.

Any monies due the student shall be refunded within thirty (30) days from the termination date.
